Why this fiscal note differs from previous version/comments:

This revised fiscal note reflects a funding level of \$400.0 for pass-through grants in FY20. Additionally, the following intent language will be added:

It is the intent of the legislature that grant funding be divided 50% to rural school districts and 50% to urban school districts. Further, it is the intent of the legislature that the Suicide Prevention Council and the Department of Education and Early Development work together to develop a long-term sustainability plan for suicide prevention training. The plan should include implementation of a "Train the Trainer" model so districts can provide ongoing training. The plan should be submitted to the Presiding Officers of the legislature and the Legislative Finance Division by December 1, 2019.

FISCAL NOTE ANALYSIS

STATE OF ALASKA
2019 LEGISLATIVE SESSION

Analysis

Per AS 44.66.010(a)(7) the Statewide Suicide Prevention Council is scheduled to terminate on June 30, 2019. This bill extends the Statewide Suicide Prevention Council's sunset date to June 30, 2027. The council serves as the State's central agency for advising the legislature and governor on the actions that can and should be taken to reduce suicide and its effect on individuals, families, and communities.

The council is staffed by a program assistant and an executive director. The council's executive director also serves as the executive director for the Alaska Mental Health Board (AMHB) and the Advisory Board on Alcoholism and Drug Abuse (ABADA). The co-location is formalized by a memorandum of agreement between the three entities and facilitates collaboration through shared resources. Per the agreement, AMHB and ABADA pay the personal services and travel costs for the executive director.

Travel funds allow the council to hold meetings throughout the state to allow maximum input/participation from community-based suicide prevention coalitions, their partners, and individual Alaskans into the decision-making process of the council.

Services funds include rental space, printing, Internet Technology (IT) support, phones, mailing, departmental shared services charges and contractual fees for travel desk support.

Developing and implementing a statewide suicide prevention plan is one of the council's most significant statutory duties.

A revised plan for the five year period 2018 - 2022, titled "Recasting the Net", was issued January 2018. The updated plan moves from a system focused on intervention to one that emphasizes prevention by promoting the health of people, families, and communities. The statewide plan is aligned with the National Strategy for Suicide Prevention and the American Indian and Alaska Native National Suicide Prevention Strategic Plan.

It is the intent of the legislature that grant funding be divided 50% to rural school districts and 50% to urban school districts. Further, it is the intent of the legislature that the Suicide Prevention Council and the Department of Education and Early Development work together to develop a long-term sustainability plan for suicide prevention training. The plan should include implementation of a "Train the Trainer" model so districts can provide ongoing training. The plan should be submitted to the Presiding Officers of the legislature and the Legislative Finance Division by December 1, 2019.
