FISCAL NOTE ANALYSIS

STATE OF ALASKA
2019 LEGISLATIVE SESSION**Analysis**

This bill overhauls the licensing statute for alcohol related businesses and includes minor alignments in the crimes and offenses related to underage conduct involving alcohol. Offenses related to the underage consumption and possession of alcohol were amended under SB165 in 2016 (Chapter 32 SLA 16). This bill applies a similar methodology to the offense of *purchase by a person under 21 years of age*.

Minors cited for this offense receive a fine of \$500.00 that may be reduced to \$50.00 by the District Court in the minor completes an alcohol safety action program, juvenile safety action program, or community diversion panel.

This bill will have no fiscal or programmatic impact on the Department of Health and Social Services, Division of Juvenile Justice.
