## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2018 LEGISLATIVE SESSION**Analysis**

This bill provides that the legislature may appropriate up to half of the proceeds of the alcoholic beverage excise tax to the Community Assistance Program under AS 29.60.250.

The alcoholic beverage excise tax is collected by the Department of Revenue. Half of the tax revenue is distributed to the alcohol and other drug abuse treatment and prevention fund established in AS 43.60.050. Refunds of biennial alcohol license fees to municipalities under AS 04.11.610 are paid from the balance of excise tax collected and deposited into the general fund. This legislation does not modify the statutory requirement for these reimbursements nor impact the reimbursement process.

The Alcohol and Marijuana Control Office does not anticipate direct fiscal impact from this legislation at this time.
