FISCAL NOTE ANALYSIS

**Analysis**

The proposed legislation repeals the Alaska Public Broadcasting Commission effective June 30, 2019, and transfers all commission assets to the Department of Administration. The Public Broadcasting Radio component provides state grants to local radio broadcast stations as approved by the Public Broadcasting Commission.
