FISCAL NOTE ANALYSIS

STATE OF ALASKA
2020 LEGISLATIVE SESSION**Analysis**

SB 68 establishes an advanced practice permit for dental hygienists under AS 08.32 (Dental Hygienists and Assistants). This legislation would allow those holding an advanced practice permit to provide certain dental hygiene procedures outside of a dental office in specific circumstances.

SB 68 amends the Title 21 (Insurance) statutes by adding dental hygienists with advanced practice permits to the definition of "provider" under AS 21.36.090(d). AS 21.36.090(d) prohibits a person from practicing or permitting "unfair discrimination against a person who provides service covered under a group health insurance policy that extends coverage on an expense incurred basis, or under a group service or indemnity type contract issued by a health maintenance organization or nonprofit corporation, if the service is within the scope of the provider's occupational license."

The Division of Insurance does not anticipate a fiscal impact with the passage of SB 68.
