FISCAL NOTE ANALYSIS

2019 LEGISLATIVE SESSION**Analysis**

This bill creates a framework for the Department of Health & Social Services to make adjustments to the Medicaid program in FY 2020 and beyond. With the new flexibility sought from the Centers for Medicare & Medicaid Services (CMS) as authorized by this bill, a continuum of coverage for low income Alaskans will be created.

Under this legislation, the Department of Health and Social Services would no longer be required to cover individuals only Medicaid eligible due to Medicaid expansion. The bill does not have a fiscal impact on the Department of Corrections because it removes the requirement for coverage, but does not exclude those individuals from coverage.

When Alaska became a Medicaid expansion state there was significant impact on the inmate population. More than 95 percent of the department's inmate population are now Medicaid eligible based on income when not incarcerated.

Medicaid does not pay for healthcare during incarceration, however, it does pay when an inmate leaves the correctional facility for 24 hours or more, such as for treatment in a hospital or long-term care facility. When Alaska implemented Medicaid expansion, the department did a five-year review of hospitalizations and estimated that approximately 150 inmates per year were hospitalized for 24 hours or more. The annual cost for those hospitalizations ranged from \$5.5 million to \$7.5 million. The department's budget was reduced by \$6.0 million after Medicaid expansion was implemented. Were the decision made by the Department of Health and Social Services to no longer cover the expansion population, the estimated cost of those hospitalizations in FY2020 would be between \$7.0 million and \$9.0 million.
