FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2019 LEGISLATIVE SESSION

**Analysis**

This bill will provide an extension of authority to prescribe emergency psychotropic medications to the specified mid-level practitioners and will likely reduce the workload burden on psychiatrists and other physicians in psychiatric treatment settings.

This bill will require changes to existing Health Facilities Licensing and Certification regulations. Regulation work is completed in the Medical Assistance Administration component. Implementation of this bill is within normal scope of work therefore this is a zero fiscal note.
