FISCAL NOTE ANALYSIS

STATE OF ALASKA
2019 LEGISLATIVE SESSION**Analysis**

The Senate Joint Resolution proposes amendments to Article IX section 12 of the Alaska Constitution. The resolution would require the governor to submit a separate appropriations bill for the funding of public K-12 schools. The resolution adds a subsection to Article IX, section 12, which would require the legislature to pass and submit the K-12 public education appropriation bill to the governor by the 45th day of the regular legislative session. The proposed amendments to Article IX, section 12, would be placed before the voters of the state at the next general election in conformity with the Alaska Constitution.

There is no fiscal impact to the Department of Education & Early Development under this resolution.

The funding mechanism is a general fund transfer to the Public Education Fund (PEF). The fiscal note effect for FY2020 through FY2025 is reported in the fiscal note for the PEF, as the funding is deposited to the PEF not into the Foundation Program funding component. The above analysis is presented here for explanation purposes only.
