"An Act relating to assault in the first degree; relating to harassment; relating to sex offenses; relating to the definition of 'dangerous instrument'; providing for an aggravating factor at sentencing for strangulation that results in unconsciousness; relating to the duties of the prosecuting attorney; and relating to victim notifications."

Insert "**relating to sentencing**;"

Page 3, following line 13:

Insert new bill sections to read:

\*\* **Sec. 5.** AS 12.55.027(d) is amended to read:

(d) A court may **not** grant credit against a sentence of imprisonment for time spent **in a private residence or** under electronic monitoring [IF THE PERSON HAS NOT COMMITTED A CRIMINAL OFFENSE WHILE UNDER ELECTRONIC MONITORING AND THE COURT IMPOSES

RESTRICTIONS ON THE PERSON'S FREEDOM OF MOVEMENT AND BEHAVIOR WHILE UNDER THE ELECTRONIC MONITORING PROGRAM, INCLUDING REQUIRING THE PERSON TO BE CONFINED TO A RESIDENCE EXCEPT FOR A

(1) COURT APPEARANCE;

(2) MEETING WITH COUNSEL; OR

(3) PERIOD DURING WHICH THE PERSON IS AT A LOCATION ORDERED BY THE COURT FOR THE PURPOSES OF EMPLOYMENT, ATTENDING EDUCATIONAL OR VOCATIONAL TRAINING, PERFORMING COMMUNITY VOLUNTEER WORK, OR ATTENDING A REHABILITATIVE ACTIVITY OR MEDICAL APPOINTMENT].

\* **Sec. 6.** AS 12.55.027(e) is amended to read:

(e) If a defendant intends to claim credit toward a sentence of imprisonment for time spent in a treatment program [OR UNDER ELECTRONIC MONITORING] either as a condition of probation or as a condition of bail release after a petition to revoke probation has been filed, the defendant shall file notice with the court and the prosecutor 10 days before the disposition hearing. The notice shall include the amount of time the defendant is claiming. The defendant must prove by a preponderance of the evidence that the credit claimed meets the requirements of this section. A court may not consider, except for good cause, a request for credit made under this subsection more than 90 days after the disposition hearing."
