Pursuant to adjournment the House was called to order by Speaker Edgmon at 10:32 a.m.

Roll call showed 30 members present. Representatives Carpenter, Jackson, Neuman, Rauscher, Revak, and Story had been excused from a call of the House today. Representative Kreiss-Tomkins was absent and his presence was noted later.

Representative Thompson moved and asked unanimous consent that Representatives Rasmussen, Shaw, and Tuck be excused from a call of the House today. There being no objection, it was so ordered.

The invocation was offered by the Chaplain, Representative Tilton. Representative Drummond moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
