Insert a new subsection to read:

"(b) The amount necessary for state aid for costs of school construction under AS 14.11.100, after the appropriation made in sec. 31(n), ch. 1, FSSLA 2019, estimated to be \$48,910,250, is appropriated from the general fund to the Department of Education and Early Development for the fiscal year ending June 30, 2020."

Senators Wielechowski, Kiehl, Kawasaki, Begich, Olson, Stevens, Stedman, Bishop, Giessel moved and asked unanimous consent to be shown as cosponsors on Amendment No. 2. Without objection, it was so ordered.

Page 20, line 7, following "11(a)": Insert "and (d)"

Senators Hoffman, Bishop, Stedman, Gray-Jackson, Stevens, Begich, Wielechowski, Kiehl, Kawasaki, Giessel moved and asked unanimous consent to be shown as cosponsors on Amendment No. 3. Without objection, it was so ordered.

July 29, 2019

Senator Olson moved for the adoption of Amendment No. 3. Senator Hoffman objected, then withdrew his objection. There being no further objection, Amendment No. 3 was adopted.

(g) The amount necessary, when added to the appropriation made in (f) of this section, to fund the total amount authorized under AS 37.13.145(b) for transfer by the Alaska Permanent Fund Corporation on June 30, 2019, estimated to be \$915,490,500, is appropriated from the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for the fiscal year ending June 30, 2020, for the payment of a supplemental permanent fund dividend, and for administrative and associated costs, on or before May 1, 2020, to eligible individuals who received a 2019 permanent fund dividend."

Page 18, line 10: Delete "and (e)" Insert "and (e) - (g)"

Page 20, line 3: Delete "(f) - (i)" Insert "(f) - (h)"

Senator Wilson moved for the adoption of Amendment No. 4. Objections were heard.
