6 appropriated in sec. 23(d), ch. 8, SLA 2020, estimated to be \$1,225,500,000, is appropriated
7 from the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for
8 the payment of supplemental 2020 permanent fund dividends to eligible individuals who
9 received a 2020 permanent fund dividend and for administrative and associated costs for the
10 fiscal year ending June 30, 2021."

26 * **Sec. 60.** Sections 4 - 11, 13 - 20, 22 - 29, 58, and 59 of this Act take effect immediately
27 under AS 01.10.070(c).

28 * **Sec. 61.** Sections 12, 21, 36(h), 37, 38(b), 47(m), and 49(i) of this Act take effect June 30,
29 2021.

30 * **Sec. 62.** Sections 43(c), (e), (g), (i), and (k) of this Act take effect January 1, 2022.

31 * **Sec. 63.** Except as provided in secs. 60 - 62 of this Act, this Act takes effect July 1, 2021."
