4 agency, or political subdivision of the state not require an individual to be vaccinated against  
5 COVID-19 for the individual to access an area or service that is open to the public. It is the  
6 intent of the legislature that a state agency or political subdivision of the state not adopt or  
7 issue a regulation, ordinance, order, or similar policy that requires an individual to be  
8 vaccinated against COVID-19 for the individual to exercise a right or receive a benefit that is  
9 available to the public."
