A BILL**FOR AN ACT ENTITLED**

1 **"An Act relating to the compensation of certain public officials, officers, and employees**
 2 **not covered by collective bargaining agreements; and providing for an effective date."**

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 * **Section 1.** AS 39.27.011(a) is repealed and reenacted to read:

5 (a) The following monthly basic salary schedule is approved as the pay plan
 6 for classified and partially exempt employees in the executive branch of the state
 7 government who are not members of a collective bargaining unit established under the
 8 authority of AS 23.40.070 - 23.40.260 (Public Employment Relations Act) and for
 9 employees of the legislature under AS 24:

* **Sec. 2.** AS 39.27.011(e) is amended to read:

(e) Effective July 1, **2023** [2014], the amounts set out in the salary schedule contained in (a) of this section are increased by **2.5** [ONE] percent.

* **Sec. 3.** AS 39.27.011(f) is repealed.

* **Sec. 4.** The uncodified law of the State of Alaska is amended by adding a new section to read:

SALARY INCREASES FOR CERTAIN EXEMPT OFFICERS AND EMPLOYEES OF THE EXECUTIVE BRANCH. The salary increases under AS 39.27.011(a), as repealed

1 and reenacted by sec. 1 of this Act, and AS 39.27.011(e), as amended by sec. 2 of this Act,
 2 apply to public officers who are in the exempt service under AS 39.25.110 and who are not
 3 members of a collective bargaining unit established under AS 23.40.070 - 23.40.260 (Public
 4 Employment Relations Act) or otherwise covered by AS 39.27.011(a). In this section, "public
 5 officers" includes permanent and temporary employees in the executive branch, not including
 6 the governor, the lieutenant governor, or the heads of principal departments of the executive
 7 branch.

8 * **Sec. 5.** The uncodified law of the State of Alaska is amended by adding a new section to
 9 read:

10 SALARY INCREASES FOR CERTAIN EMPLOYEES OF THE JUDICIAL
 11 BRANCH. The salary increases under AS 39.27.011(a), as repealed and reenacted by sec. 1 of
 12 this Act, and AS 39.27.011(e), as amended by sec. 2 of this Act, apply to permanent and
 13 temporary employees and magistrates in the judicial branch of the state government, other
 14 than justices and judges, who are not members of a collective bargaining unit established
 15 under AS 23.40.070 - 23.40.260 (Public Employment Relations Act) and who are not
 16 otherwise covered by AS 39.27.011(a).

17 * **Sec. 6.** The uncodified law of the State of Alaska is amended by adding a new section to
 18 read:

19 SALARY INCREASES FOR CERTAIN EMPLOYEES OF THE UNIVERSITY OF
 20 ALASKA. The employees of the University of Alaska who are not members of a collective
 21 bargaining unit are entitled to receive salary increases in accordance with the compensation
 22 policy of the Board of Regents of the University of Alaska.

23 * **Sec. 7.** This Act takes effect July 1, 2022.
