Analysis

This bill extends the sunset date for existing funding allocations for program and grant distributions under AS 23.15.835(d) for the Alaska Technical and Vocational Education Program (TVEP) through June 30, 2024. Funding authorization for the Unemployment Insurance component was included in the FY2022 Governor Amended request.

This legislation does not change the budgeted authorization needed for the Unemployment Insurance component.
