## FISCAL NOTE ANALYSIS

STATE OF ALASKA

## Analysis

The proposed bill will change APFC's Board composition and increase the seat count by one. With the terms outlined in Section 9 (a), there is a potential that as of January 1, 2023, APFC could have an entirely new Board, except for the Commissioner of Revenue. The costs associated with establishing a new Board and adding a member are included in the following:

**Honorarium:**

Per AS 37.13.090, board members are eligible for "an honorarium of \$400 for each day spent at a meeting of the board or at a meeting of a subcommittee of the board or at a public meeting as a representative of the board."

In FY2023, APFC currently has ten meeting days scheduled. With \$400 per trustee/ per meeting day honorarium, APFC's budget will need to increase from \$24,500 to \$28,500.

Estimated 5 meeting days (Jan 1- June 30) \$400 x 2 new Trustees = \$800 x 5 meeting days = \$4,000 increase.

**Travel:**

The proposed FY2023 Trustee Travel in the Governor's budget is \$18,000. The average cost for a trustee to travel to a board meeting is \$850.00. Several members are currently located in Anchorage, which eliminates travel costs for meetings that take place in Anchorage. Adding an additional Trustee will increase the travel budget by roughly \$5,950= 7 meetings X \$850.

**Trustee Orientation:**

Upon appointment, each Trustee will participate in Trustee orientation. These educational sessions allow the members to meet staff and go over topics such as the legal and fiduciary responsibilities of a trustee, board member logistics, the strategic plan, Board Governance, Committee Assignments, etc. These sessions can be attended virtually but are preferred to be in-person.

Travel costs will be equivalent, if not less than those associated with a Board meeting  
7 trustees x \$850 = \$5,900.

Honorarium will be 6 public members X \$400 per day = \$2,400.

**Board Meetings:**

It is customary for the board to choose locations around the state to host APFC board meetings, giving the public an opportunity to participate in their communities. The FY2023 budget is \$79,100 for hosting seven meetings in the following locations; Juneau, Anchorage, and Kenai. The estimated cost per meeting is approximately \$11,300. Without knowing if these locations will remain the same or if special meetings will be added to the schedule, related expenses are indeterminate.

Honorarium: \$4,000

Travel: \$5,950

Trustee Orientation: \$8,300

Board Meetings: indeterminate

**Total: \$18,250**

Additional expenses will be built into the FY2024 budget and all future budgets based on actuals.
