**STATE OF ALASKA
2022 LEGISLATIVE SESSION****Analysis**

This bill prohibits dress codes that restrict historical or natural hairstyles for students or employees. Conversely, a dress code may restrict hairstyles to comply with health or safety law, regulation, or ordinance.
