FISCAL NOTE ANALYSIS

STATE OF ALASKA
2021 LEGISLATIVE SESSION

Analysis

This bill amends AS 44.66.010(a)(6) to extend the sunset date of the Special Education Service Agency (SESA) from June 30, 2021 to June 30, 2028.

This bill establishes an immediate effective date.

Per AS 14.30.650, the Department of Education and Early Development's FY2022 budget includes \$2,404.4 to provide grant funding to support SESA's statutory responsibilities. Funding is determined by multiplying eighteen dollars and sixty five cents by the average daily membership in the preceding fiscal year (FY2021 projected) as determined under AS 14.17.600 ($\$18.65 \times 128,923.91 = \$2,404.4$).
