FISCAL NOTE ANALYSIS

STATE OF ALASKA
2021 LEGISLATIVE SESSION**Analysis**

SB 120 re-establishes the Administrative Regulation Review Committee, which was repealed in 2018, as a permanent interim committee of the legislature. This legislation would require that all proposed regulations be sent to the committee to review and comment on before adoption. The Department of Law reviews regulations adopted under the Administrative Procedure Act (APA) to ensure that each regulation is within the scope of authority conferred by statute and follows the adoption process laid out in the APA. This legislation would add an additional step to that APA process.

If SB 120 becomes law, the Department of Law will need to provide training to covered state agencies and to update the Drafting Manual for Administrative Regulations to reflect the new process. The Department of Law attorneys may also provide additional legal advice if asked to discuss legal concerns raised by the committee. Finally, the Department of Law will receive and review any notification from the Legislative Affairs Agency that a regulation fails to meet the standards.

Based on its previous experience and staffing from when the Administrative Regulations Review Committee was previously established in statute, the Department of Law anticipates that this work can be absorbed by existing staff. The Department of Law does not anticipate any fiscal impact if this bill becomes law.
