Pursuant to adjournment the House was called to order by Speaker pro tempore Patkotak at 10:06 a.m.

Roll call showed 40 members present.

The invocation was offered by the Chaplain, Representative Kurka. Representative Tuck moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
