Pursuant to adjournment the House was called to order by Speaker Stutes at 12:08 p.m.

Roll call showed 40 members present.

The invocation was offered by the Chaplain, Representative Drummond. Representative Thompson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

With the greatest respect for the diversity of beliefs of all the Alaskans we represent, I offer the following prayer:

Today is Orthodox Easter Sunday. Millions of Orthodox Christians around the world today are celebrating the resurrection of Christ. Greek Orthodox are greeting each other with "Χριστός ἀνέστη," or "Christ is Risen" and responding with "Ἀληθῶς ἀνέστη," or "Truly He is Risen."

In our Greek Orthodox church in Anchorage, the Lord's Prayer is recited in the many languages which are represented in the ethnicities of our parish, from English and Greek to Ukrainian, Romanian, Armenian, Arabic, and even French. Today I'll recite the Lord's Prayer in Greek and you all are welcome to say it with me in English afterward.

Αμὴν.
