**MESSAGES FROM THE GOVERNOR**

The following letter dated October 13 was received:

"Dear President Micciche and Speaker Stutes:

Based on the Division of Homeland Security and Emergency Management's (DHS&EM) continuing programmatic work with disaster applicants and Federal Emergency Management Agency (FEMA), project adjustments will require additional authority for the 2012 September Storm Disaster (DR4094). In these cases, the Public Assistance Program project was written and approved by FEMA after the state disaster finance plans had been submitted to legislative leadership. Therefore, these project costs exceeded the initial estimates established in the original finance plans.

1. The 2012 September Storm Disaster (DR-4094-AK) requires an increase of federal authority in the amount of \$1,000,000. The reason for this change is due to the increased estimate of Petersville Road with the Department of Transportation (Project Worksheet 83) and the pending increase for direct administrative project worksheets to be approved at the end of the disaster for reimbursement.
