Pursuant to adjournment the House was called to order by Speaker Stutes at 10:06 a m.

Roll call showed 35 members present. Representatives Kaufman, Kreiss-Tomkins, McCarty, and Snyder had been excused from a call of the House today. Representative Fields was absent, and his presence was noted later.

The invocation was offered by the Chaplain, Pastor Tari Stage-Harvey of Shepherd of the Valley Lutheran Church. Representative Thompson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
