The House was called to order by Speaker Stutes at 1:08 p.m.

Roll call showed 33 members present. Representatives Edgmon, Kreiss-Tomkins, and Zulkosky were absent and their presence was noted later. Representative Rauscher was absent and later excused (page 2892). Representatives McCarty, Nelson, and Shaw were absent.
