Pursuant to adjournment the Senate was called to order by President Micciche at 10:48 a.m.

The roll showed eighteen members present. Senators Shower, von Imhof were absent.

The prayer was offered by the Chaplain, Senator Holland. Senator Hoffman moved and asked unanimous consent the prayer be spread. Without objection, it was so ordered.

Heavenly Father,

We invite You to preside over this meeting. Even if we have different opinions, give us unity of spirit. Help us to each listen politely as others share their points of view. Help us to work as a unified team in combining ideas for a great outcome. Help us to work as a whole rather than individuals trying to promote our own agendas. Senator Hughes led the Senate in the Pledge of Allegiance.

Senator Hughes moved and asked unanimous consent Senators Shower, von Imhof be excused from a call of the Senate today. Without objection, Senators Shower, von Imhof were excused.

Senator Hughes moved and asked unanimous consent the journals for the one hundred second through one hundred fourth legislative days be approved as certified by the Secretary. Without objection, it was so ordered.

HB 76

Message was read stating the Governor signed the following bill on April 30 and transmitted the engrossed and enrolled copies to the Lieutenant Governor's Office for permanent filing:

SENATE CS FOR CS FOR HOUSE BILL NO. 76(FIN) am S "An Act extending the January 15, 2021, governor's declaration of a public health disaster emergency in response to the novel coronavirus disease (COVID-19) pandemic; approving and ratifying declarations of a public health disaster emergency; providing for a financing plan; making temporary changes to state law in response to the COVID-19 outbreak in the following areas: emergency powers of the governor; emergency powers of the commissioner of health and social services; occupational and professional licensing, practice, and billing; telehealth; charitable gaming and online ticket sales: access to federal stabilization funds; wills; unfair or deceptive trade practices; school operating funds; workers' compensation; program execution; civil liability; immunity from liability and disciplinary action for occupational licensees for exposure of clients to COVID-19; immunity from liability for persons engaging in business and their employees for exposure of customers to COVID-19; abortion funding; and personal objections to the administration of COVID-19 vaccines; and providing for an effective date."

Executive Proclamation

WHEREAS, since March 11, 2020 the state of Alaska has been operating under a Disaster Declaration related to the worldwide COVID-19 pandemic; and

WHEREAS, the State of Alaska has engaged in extraordinary efforts to mitigate the effects of the SARS-CoV-2 virus on its citizens, and has been successful in keeping infections, hospitalization, and death rates among the lowest in the country as reflected by the data; and

WHEREAS, on December 11, 2020, the Food and Drug Administration (FDA) issued an Emergency Use Authorization (EUA) to begin immediate nationwide distribution of the Pfizer vaccination. Soon after, the FDA issued additional EUAs for vaccines manufactured by Moderna and Johnson & Johnson; and

WHEREAS, Alaska has received and distributed vaccines throughout the state and, at times, has had the highest vaccination rate in the United States; and

WHEREAS, the Commissioner of Health and Social Services has certified, in his April 30, 2021 memo, that Alaska is currently able to meet the continuing challenges of the COVID-19 pandemic without an active Disaster Declaration under AS 26 23 020

NOW THEREFORE, I, Mike Dunleavy, GOVERNOR OF THE STATE OF ALASKA, under the authority granted by the Alaska State Legislature in HB76 Chapter No. 2, SLA 2021, which ratified the Disaster Declaration issued on January 14, 2021, do hereby proclaim that the Disaster Declaration shall end, effective immediately.

- **Sec. 14.20.098. Teacher dwelling.** (a) A person may not instruct students as a full-time teacher in continuous employment working more than 30 hours each week in a public school of the state unless the person maintains a dwelling in the state when instructing students.
- (b) This section does not apply if the employer or the employer's designee has made a specific written determination that requiring a teacher to maintain a dwelling in the state is impracticable to meet the educational needs of the public school.
 - (c) In this section,
- (1) "dwelling" means a space intended to be occupied as a residence;
- (2) "full-time teacher" means a teacher occupying a position requiring teaching on a regular basis for the normal work period each day or week at a teaching assignment, excluding teaching as an assistant or graduate assistant or teaching on a substitute, temporary, or per diem basis."

Renumber the following bill section accordingly.

Page 3, following line 19:

Insert a new bill section to read:

"* Sec. 10. The uncodified law of the State of Alaska is amended by adding a new section to read:

APPLICABILITY. AS 14.20.098, added by sec. 8 of this Act, applies to contracts entered into or renewed on or after the effective date of sec. 8 of this Act."
