1 Page 1, line 1, following "weapons": (title amendment)

2 Insert "; and relating to the protection of constitutional rights during a disaster  
3 emergency"

5 Page 1, line 4:

6 Delete "the right to keep and bear arms; disaster"

7 Insert "certain constitutional rights and restrictions on firearms and other  
8 weapons during a disaster emergency"

9

10 Page 1, line 8, through page 2, line 8:

11 Delete all material and insert:

12 "(1) relating to a firearm, a firearm part, a firearm accessory,  
13 ammunition, or other weapon for personal use if that order, proclamation, regulation,  
14 ordinance, or policy

15 (A) forbids the possession, use, or transfer of a firearm, a  
16 firearm part, a firearm accessory, ammunition, or other weapon for personal  
17 use;

18 (B) orders the seizure or confiscation of a firearm, a firearm  
19 part, a firearm accessory, ammunition, or other weapon for personal use;

20 (C) places limits on the quantity of firearms, firearm parts,  
21 firearm accessories, ammunition, or other weapons for personal use that may  
22 be sold or serviced or places other restrictions on the sale or service of  
23 firearms, firearm parts, firearm accessories, ammunition, or other weapons for

1 personal use;

2 (D) unless a closure or limitation applies equally to all forms of  
3 commerce within a jurisdiction, closes or limits the operating hours of

4 (i) an entity engaged in the sale or service of firearms,  
5 firearm parts, firearm accessories, ammunition, or other weapons for  
6 personal use; or

7 (ii) an indoor or outdoor shooting range;

8 (E) suspends or revokes a permit to carry a concealed handgun  
9 issued under AS 18.65.700, except as provided in AS 18.65.735 and  
10 18.65.740; or

11 (F) refuses to accept an application to carry a concealed  
12 handgun, provided the application contains the information required under  
13 AS 18.65.710;

14 (2) closing a church, synagogue, mosque, temple, or other place of  
15 worship;

16 (3) suppressing free speech, the freedom of the press, or the freedom of  
17 petition;

18 (4) interfering with the prohibition on unreasonable search and seizure;

19 (5) prohibiting the exercise of the privileges and immunities clause  
20 under art. IV, sec. 2, Constitution of the United States;

21 (6) depriving people of the rights of life, liberty, or property without  
22 due process;

23 (7) imprisoning a person for a debt;

24 (8) suspending

25 (A) equal protection of the law;

26 (B) habeas corpus, except in cases of rebellion or public safety;

27 (C) the right of a citizen to vote based on race, color, or gender;

28 (D) the right of privacy; or

29 (E) the right to a civil suit and trial by jury."
