9 *** Section 1.** AS 19.10.399(9) is amended to read:

10 (9) "motor vehicle" means a vehicle that is self-propelled, except for a
11 vehicle moved by human or animal power; "motor vehicle" does not include an
12 electric-assisted bicycle as defined in AS 28.90.990(a);

13 *** Sec. 2.** AS 19.10.399(16) is amended to read:

14 (16) "vehicular way or area" means a way, path, or area, other than a
15 highway or private property, that is designated by official traffic control devices or
16 customary usage and that is open to the public for purposes of pedestrian or vehicular
17 travel, and which way or area may be restricted in use to pedestrians, bicycles, or other
18 specific types of vehicles as determined by the Department of Public Safety or other
19 agency having jurisdiction over the way, path, or area; in this paragraph, "bicycle"
20 has the meaning given in AS 28.90.990(a).

21 *** Sec. 3.** AS 28.05.011(a) is amended to read:

22 (a) The commissioner of public safety shall, unless otherwise provided by
23 statute, adopt regulations in compliance with AS 44.62 (Administrative Procedure

1 Act) necessary to carry out the provisions of this title and other statutes whose
 2 administration is vested in the Department of Public Safety. The regulations must
 3 include

4 (1) rules of the road relating to the driving, stopping, standing, parking,
 5 and other conduct of vehicles, to pedestrians, and to official traffic control devices;
 6 regulations adopted under this paragraph may not prohibit the use of an electric
 7 personal motor vehicle or an electric-assisted bicycle on a sidewalk, bike path, or
 8 vehicular way or area restricted to the use of pedestrians; limitations on regulation of
 9 electric personal motor vehicles or electric-assisted bicycles imposed under this
 10 paragraph do not apply to a municipal ordinance regulating electric personal motor
 11 vehicles, electric-assisted bicycles, or specific classes of electric-assisted bicycles
 12 enacted to meet local requirements; unless otherwise specified by regulation,

13 (A) an electric-assisted bicycle is considered a bicycle and
 14 may not be regulated as another type of vehicle; and

15 (B) a user of an electric-assisted bicycle shall be afforded
 16 the same rights and be subject to the same duties as a user of a bicycle;

17 (2) minimum equipment for vehicles, including minimum standards of
 18 compliance to be met by manufacturers and vehicle sales and repairs businesses;

19 (3) inspection of vehicles other than commercial motor vehicles, and
 20 the removal of vehicles from areas of public use when they are found to be in a
 21 defective or unsafe condition;

23 (5) management of records of the Department of Public Safety

31 **Sec. 28.10.011. Vehicles subject to registration.** Every vehicle driven,

1 moved, or parked on [UPON] a highway or other public parking place in the state
2 shall be registered under this chapter except when the vehicle is

3 (1) driven or moved on a highway only for the purpose of crossing the
4 highway from one private property to another, including an implement of husbandry
5 as defined by regulation;

6 (2) driven or moved on a highway under a dealer's plate or temporary
7 permit as provided for in AS 28.10.031 and 28.10.181(j);

8 (3) special mobile equipment as defined by regulation;

9 (4) owned by the United States;

10 (5) moved by human or animal power;

11 (6) exempt under 50 U.S.C. App. 501-591 (Soldiers' and Sailors' Civil
12 Relief Act);

13 (7) driven or parked only on private property;

14 (8) the vehicle of a nonresident as provided under AS 28.10.121;

15 (9) transported under a special permit under AS 28.10.151;

16 (10) being driven or moved on a highway, vehicular way, or a public
17 parking place in the state that is not connected by a land highway or vehicular way to

18 (A) the land-connected state highway system; or

19 (B) a highway or vehicular way with an average daily traffic

2 (12) "electric personal motor vehicle" means an electric personal
3 assistive mobility device that is a self-balancing vehicle with two nontandem wheels,
4 designed to transport only one person, has an electric propulsion system, and has a
5 maximum speed of not more than 15 miles an hour; **"electric personal motor
6 vehicle" does not include an electric-assisted bicycle;**

7 * Sec. 7. AS 28.90.990(a)(18) is amended to read:

8 (18) "motor vehicle" means a vehicle **that** [WHICH] is self-propelled,
9 except **for** a vehicle moved by human or animal power; **"motor vehicle" does not
10 include an electric-assisted bicycle;**

11 * Sec. 8. AS 28.90.990(a)(19) is amended to read:

12 (19) "motorcycle" means a vehicle having a seat or saddle for the use
13 of the rider and designed to travel on not more than three wheels in contact with the
14 ground; **"motorcycle"** [THE TERM] does not include a tractor **or an electric-
15 assisted bicycle;**

17 (20) "motor-driven cycle" means a motorcycle, motor scooter,
18 motorized bicycle, or similar conveyance with a motor attached and having an engine
19 with 50 or less cubic centimeters of displacement; **"motor-driven cycle" does not
20 include an electric-assisted bicycle;**

21 * Sec. 10. AS 28.90.990(a) is amended by adding new paragraphs to read:

22 (33) "bicycle" includes an electric-assisted bicycle;

23 (34) "class 1 electric-assisted bicycle" means a bicycle equipped with
24 an electric motor that provides assistance only when the rider is pedaling and that
25 stops providing assistance when the bicycle reaches the speed of 20 miles per hour;

26 (35) "class 2 electric-assisted bicycle" means a bicycle equipped with
27 an electric motor that may be used exclusively to propel the bicycle and that stops
28 providing assistance when the bicycle reaches the speed of 20 miles per hour;

29 (36) "class 3 electric-assisted bicycle" means a bicycle equipped with
30 an electric motor that provides assistance only when the rider is pedaling and that
31 stops providing assistance when the bicycle reaches the speed of 28 miles per hour;

(37) "electric-assisted bicycle" means a bicycle that

(A) is designed to travel with not more than three wheels in contact with the ground;

(B) has fully operative pedals for human propulsion;

(C) has a seat or saddle for use of the rider;

(D) is equipped with an electric motor that has a power output of not more than 750 watts; and

(E) is a class 1, class 2, or class 3 electric-assisted bicycle.

* **Sec. 11.** AS 41.23 is amended by adding new sections to article 1 to read:

Sec. 41.23.295. Electric-assisted bicycles. In a management plan adopted under AS 41.23.010 - 41.23.300, the department may establish different standards for nonelectric-assisted bicycles and for each class of electric-assisted bicycle.

Sec. 41.23.300. Definitions. In AS 41.23.010 - 41.23.300,

(1) "bicycling" includes the operation of an electric-assisted bicycle;

(2) "electric-assisted bicycle" has the meaning given in AS 28.90.990(a).
