FOR AN ACT ENTITLED

1 "An Act relating to registered interior designers and interior design; establishing
2 requirements for the practice of registered interior design; relating to the State Board of
3 Registration for Architects, Engineers, and Land Surveyors; relating to liens for labor
4 or materials furnished; relating to the procurement of interior design services; and
5 providing for an effective date."

6 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

7 * **Section 1.** AS 08.48.011(b) is amended to read:

8 (b) The board consists of **13** [11] members appointed by the governor having
9 the qualifications as set out in AS 08.48.031. The board consists of two civil
10 engineers, two land surveyors, one mining engineer, one electrical **engineer, one** [OR]
11 mechanical engineer, one engineer from another branch of the profession of
12 engineering, two architects, one landscape architect, **one interior designer,** and one
13 public member.

1 * **Sec. 2.** AS 08.48.011(b), as amended by sec. 1 of this Act, is amended to read:

2 (b) The board consists of 13 members appointed by the governor having the
3 qualifications as set out in AS 08.48.031. The board consists of two civil engineers,
4 two land surveyors, one mining engineer, one electrical engineer, one mechanical
5 engineer, one engineer from another branch of the profession of engineering, two
6 architects, one landscape architect, one **registered** interior designer, and one public
7 member.

8 * **Sec. 3.** AS 08.48.011(c) is amended to read:

9 (c) Notwithstanding (b) of this section,

10 **(1) if a mining engineer who qualifies for appointment to the board**
11 **[AND IS INTERESTED IN SERVING ON THE BOARD]** is not available, the
12 governor may appoint a petroleum or chemical engineer to the seat designated for a
13 mining engineer;

14 **(2) if an electrical engineer who qualifies for appointment to the**
15 **board is not available, or if an electrical engineer occupies the seat designated for**
16 **a mechanical engineer, the governor may appoint a mechanical engineer to the**
17 **seat designated for an electrical engineer; or**

18 **(3) if a mechanical engineer who qualifies for appointment to the**
19 **board is not available, or if a mechanical engineer occupies the seat designated**

26 councils of architect examiners, engineering examiners, land surveyor examiners,
27 **registered interior designer examiners**, or landscape architect examiners, or any of
28 their subdivisions. The total amount of disbursements issued in payment of the
29 expenses incurred under this chapter may not exceed the amount of money
30 appropriated by the legislature.

1 (f) The department shall assemble statistics relating to the performance of its
2 staff and the performance of the board, including

16 guilty of (1) fraud or deceit in obtaining a certificate; (2) gross negligence,
17 incompetence, or misconduct in the practice of architecture, engineering, land
18 surveying, **registered interior design**, or landscape architecture; or (3) a violation of
19 this chapter, a regulation adopted under this chapter, or the code of ethics or
20 professional conduct as adopted by the board. The code of ethics or professional
21 conduct shall be distributed in writing to every registrant and applicant for registration
22 under this chapter. This publication and distribution of the code of ethics or
23 professional conduct constitutes due notice to all registrants. The board may revise and
24 amend its code and, upon doing so, shall immediately notify each registrant in writing
25 of the revisions or amendments. The board may, upon petition of the registrant,
26 corporation, limited liability company, or limited liability partnership, reissue a
27 certificate if a majority of the members of the board vote in favor of the reissuance.

29 **Sec. 08.48.171. General requirements and qualifications for registration.**
30 An applicant for registration as an architect, engineer, land surveyor, **registered**
31 **interior designer**, or landscape architect must be of good character and reputation and

1 shall submit evidence satisfactory to the board of the applicant's education, training,
 2 and experience. However, an applicant for registration as a land surveyor may not be
 3 required to submit evidence of more than eight years of any combination of education,
 4 experience, or training.

6 **Sec. 08.48.181. Registration upon examination.** Except as provided in
 7 AS 08.48.191, for registration as a professional architect, professional engineer,
 8 professional land surveyor, [OR] professional landscape architect, **or registered**
 9 **interior designer,** a person shall be examined in this state in accordance with the
 10 regulations of procedure and standards adopted by the board under AS 44.62
 11 (Administrative Procedure Act). The procedure and standards shall at least meet the
