FISCAL NOTE ANALYSIS

STATE OF ALASKA
2023 LEGISLATIVE SESSION**Analysis**

This bill amends Alaska Statute (AS) 11.41 by adding a new section, AS 11.41.240, establishing the crime of Assault in the Presence of a Child as a class A misdemeanor. The term assault as presented in this bill would fall under AS 11.41.200 – 11.41.230 for Assault in the first, second, or third degree.

There will be no fiscal impact.
