FISCAL NOTE ANALYSIS

Analysis

HB 19 would exempt certain qualifying vessels from state registration and numbering, and result in some registration duties performed by the Alaska Department of Motor Vehicles (DMV) transferring to be performed by the Commercial Fisheries Entry Commission (CFEC). Fees associated with those transactions would be collected by CFEC and transferred to DMV.

Registration fees collected under the statutes impacted by this legislation are collected as fund code 1216 Boat Receipts, which are currently collected by DMV and transferred to the Department of Commerce, Community, and Economic Development's Division of Community and Regional Affairs (DCRA). DCRA uses those transferred revenues to administer an annual grant to the Alaska Marine Safety Education Association (AMSEA).

Since the overall revenues to CFEC and the DMV are anticipated to continue to be sufficient to fully support the annual grant to AMSEA, the Division of Community and Regional Affairs does not anticipate fiscal impact from this legislation.
