FISCAL NOTE ANALYSIS

Analysis

This bill amends state law regarding sex offender registration requirements. The Department of Public Safety, Division of Statewide Services manages the state's sex offender registry. While the changes in the sex offender registration requirements will result in a workload increase, the department anticipates it will be able to absorb the added workload with existing resources and is therefore submitting a zero-fiscal note at this time.
