## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION**Analysis**

This bill adds to the list of parental rights regarding their student(s) participating in activities, programs, or classes involving sexual matters. It directs districts to create procedures and timelines for parental notification in order for the parents to "opt in" to those activities, classes, or programs. In addition, the parent, guardian, or foster parent must provide a list of names and pronouns that may be used to address the child to the school district for inclusion in their school record and procedures to change that provided list.

This bill provides parent, guardian, or foster parent access to their child's entire school record.

The Department does not anticipate a fiscal impact as a result of this legislation.

The effective date is July 1, 2023 (FY2024).
