FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION

**Analysis**

This bill establishes the earnings reserve account under the Constitution of the State of Alaska, and amends statute so that the Alaska Permanent Fund Corporation (APFC) shall transfer income from the permanent fund to the general fund for legislative appropriation to pay dividends.

This has no fiscal impact on the Permanent Fund Dividend Division.
