FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

Analysis

The purpose of this legislation is to reduce the number of commercial set net permits on the east side of the Cook Inlet; thereby improving profitability for the remaining set net permit holders and reducing king salmon harvest in the east side set net fishery. The bill allows for the division of an existing administrative area to establish a commercial shore set net entry permit buy-back program.

Since the provision in the bill was removed that would have required the Department of Fish and Game, Division of Commercial Fisheries to work in coordination with the Commercial Fisheries Entry Commission (CFEC) and the Department of Natural Resources to close waters associated with shore fishery leases or waters fished by CFEC permit holders involved in the buy-back program, the department no longer has an active role in the program. Therefore, the department submits a zero fiscal note.
