## Analysis

This legislation changes legal requirements related to pharmacies, pharmacists, and pharmacy benefits managers. The bill amends registration and licensing requirements for pharmacy benefits managers, requires the Division of Insurance to review and set the professional dispensing fees paid to pharmacies and pharmacists, and creates statutory prohibitions related to unfair trade in the insurance market and pharmacy selection process.

The division will require three positions to enact this legislation: one Insurance Licensing Examiner 2 position for the licensing program; one Program Coordinator 2 for the dispensing fee management and review; and one Consumer Services Specialist to monitor and manage the unfair trade practices requirements and grievance procedures. To periodically review and set professional dispensing fees, the division will require services authority to purchase cost surveys and utilize professional actuarial and consulting services. The legislation requires this review at least every five years; the division plans to complete this work every two years to ensure that the fees are adjusted often enough to be responsive to market conditions.

If this legislation is adopted, the division will require the following in each fiscal year unless otherwise specified:

**Personal Services:**

\$ 97.9	Insurance Licensing Examiner 2, range 14, in Juneau
\$132.8	Program Coordinator 2, range 20, in Anchorage
\$105.4	Consumer Services Specialist, range 16, in Anchorage

**Travel:** \$ 24.0 Travel for program development and support.

**Services:**

\$300.0	Contractual support to acquire cost surveys, actuarial review, and consultant support in dispensing fee review. Biennially in FY2025, FY2027, and FY2029.
\$ 75.0	Statewide and department core services and allocated costs (\$25.0 / position / year)

**Commodities:**

\$ 30.0	New position equipment and supplies in FY2025 only.
\$ 5.0	Annual equipment and supplies needs from FY2026 on.

Insurance licensing and regulation activities are fully funded from licensing fees collected under AS 21. In this fiscal note, revenues collected under this program are projected to be equal to the cost to implement the program.
