FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

Analysis

This bill amends Alaska Statute (AS) 18.65.240(a) under the Alaska Police Standards Council requiring police officer training requirements to include completion of cultural training supervised by an indigenous coordinator or indigenous entity in the state that is related to addressing the rates of missing and murdered indigenous persons. While this will have a fiscal impact, the department anticipates being able to absorb these costs at this time.

The bill amends AS 44.41 adding a new section, AS 44.41.023, to require the department to employ at least two persons to investigate missing and murdered indigenous persons. The investigators would also be required to act as liaisons between law enforcement agencies, communities, and federally recognized tribes.

The department currently employs four investigators and two tribal liaisons that focus on Trooper specific cases, community outreach and collaboration, and missing person initiatives statewide. Since these specific positions exist and were funded in FY2024, there is no fiscal impact.

The bill establishes a Missing and Murdered Indigenous Persons Review Commission with the department. The department anticipates that it would need a position to coordinate and administer the commission and assist in drafting the requested report.

The bill requires the department to conduct a needs assessment to determine how to increase protective and investigative resources for reporting cases of missing and murdered indigenous persons within the state criminal justice system with the Governor's office and stakeholder organizations to reduce barriers and increase information sharing.

The department would offer an open procurement for a professional services contract for the needs assessment at an estimated cost to work the assessment; travel for the contractor and stakeholders; and preparing a report for the legislator at a cost of \$400.0.
