Analysis

The University of Alaska Major Maintenance and Modernization Fund Act aims to establish a fund, known as the "University of Alaska Major Maintenance and Modernization Fund," to ensure the ongoing maintenance and modernization of the UA's facilities and infrastructure.

A minimum of \$35 million can be funded annually through the language section of the state's annual appropriation bill, providing a stable and predictable source of funding for critical infrastructure needs at the UA.

Assuming stable operating fund increases, UA commits to contributing \$1-2 million annually beginning in 2028 and growing to \$10 million by 2035.
