## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION**Analysis**

The bill amends Alaska statute by adding a new definition for commercial sexual exploitation and requires the Department of Family and Community Services to adopt a uniform screening tool, screen minors for potential victimization and sexual abuse, trafficking, and exploitation, and investigate the experiences of missing children in need of aid once they have been located.

The Office of Children's Services currently employs a screening tool to determine if a child in the department's custody is at risk or was a victim of sex trafficking. When a child be suspected of being a victim, law enforcement is notified immediately. This legislation aligns with current division policy and practice and will have not fiscal impact.
