The ANLPAC shall be transferred to the Department of Education and Early Development (DEED) under AS 14.07.200. The position that supports the program will be moved from the Department of Commerce, Community, and Economic Development (DCCED) to DEED using the budget process.

The ANLPAC program is supported by one Research Analyst 3 position with a cost of \$137.9 and chargeback costs of \$16.5 annually. One-time cost of \$5.0 would be needed to purchase necessary equipment and supplies.

Travel costs for the council members will be budgeted at \$14.0 annually.

This Legislation makes a number of changes to the criminal code by increasing the penalty for individuals who manufacture or deliver a controlled substance in violation of certain controlled substance laws, and a person dies as a direct result of ingesting the substance. The bill also amends the crime of stalking to include violations of a stalking or sexual assault protective orders and creates a new crime of assault in the presence of a child.

The DOC does not have sufficient data to project the full impacts of changes to the criminal code on the daily prison population; however, the department does not anticipate any significant fiscal impact with these changes and can absorb any increases within the current capacity and resources based on current inmate population counts.

This Legislation also requires the Department of Corrections to enter into a contract with a statewide Alaska Native Organization, identifies the make-up of the membership of the organization and a specific requirement of outreach to other agencies, in order to conduct a study of the disproportionate make-up of the Alaska Natives in Alaska prisons to the statewide Alaska Native population. It also requires a reporting of the findings to the Legislature. Based on prior studies of the inmate population, it is estimated that the cost would be approximately \$250.0 up to \$500.0. Based on information provided the department is seeking a one time increment in the amount of \$375.0.

## Analysis

This bill makes a number of changes to the criminal code.

It increases penalties for certain offenses involving controlled substances. If a person distributes a controlled substance in violation of AS 11.71.010 and AS 11.71.021 and a person dies from ingesting that controlled substance the crime will be murder in the second degree. It also makes it misconduct involving a controlled substance in the first degree (AS 11.71.021) if a person delivers a controlled substance to a person who is mentally incapable, incapacitated, or unaware that a controlled substance is being delivered.

This legislation also makes a number of other changes to the criminal code such as making it a class A misdemeanor to assault another person in the presence of a child, amending the definition of "crime involving domestic violence" to include interfering with a report of a crime of domestic violence and unlawful contact, and allowing testifying witnesses to summarize the statements of others at the grand jury phase of a case. The bill also eliminates the phrase "child pornography" from statute and replaces it with "child sexual abuse material." This does not alter the legal status of the amended crimes. The Criminal Division does not anticipate a fiscal impact from these sections of the bill.

This legislation requires the Criminal Division to file a petition for civil involuntary commitment under AS 47.30 before dismissal of a criminal case due to the defendant being incompetent to stand trial in certain cases. For the cases where the prosecutor must then notify the Civil Division that the petition has been filed and, within 24 hours after the filing of the petition, provided the court's findings to the Civil Division. The process of filing a petition for civil involuntary commitment is not in which prosecutors are currently routinely involved. Therefore, the Criminal Division is requesting one additional attorney, one paralegal, and one associated law office assistant all located in Anchorage. Between 2020 and 2022 there were approximately 178 cases dismissed because the defendant was not competent and either not restorable or while the person was still on the restoration waitlist.

Additionally, this legislation requires the Criminal Division to notify the victim in a criminal case that was dismissed because the person was not competent to stand trial of the time and place of an involuntary commitment hearing under AS 47.30, the length of time for which the respondent is committed and the findings made by the court, and when the respondent is discharged from commitment. The Criminal Division does not currently receive this type of information and, therefore, is currently unable to notify victims. A former defendant could be civilly committed for a lengthy period of time which requires periodic hearings. Therefore, each case which requires this type of notification will require continued contact with the victim.

The expenses for the above mentioned positions include:

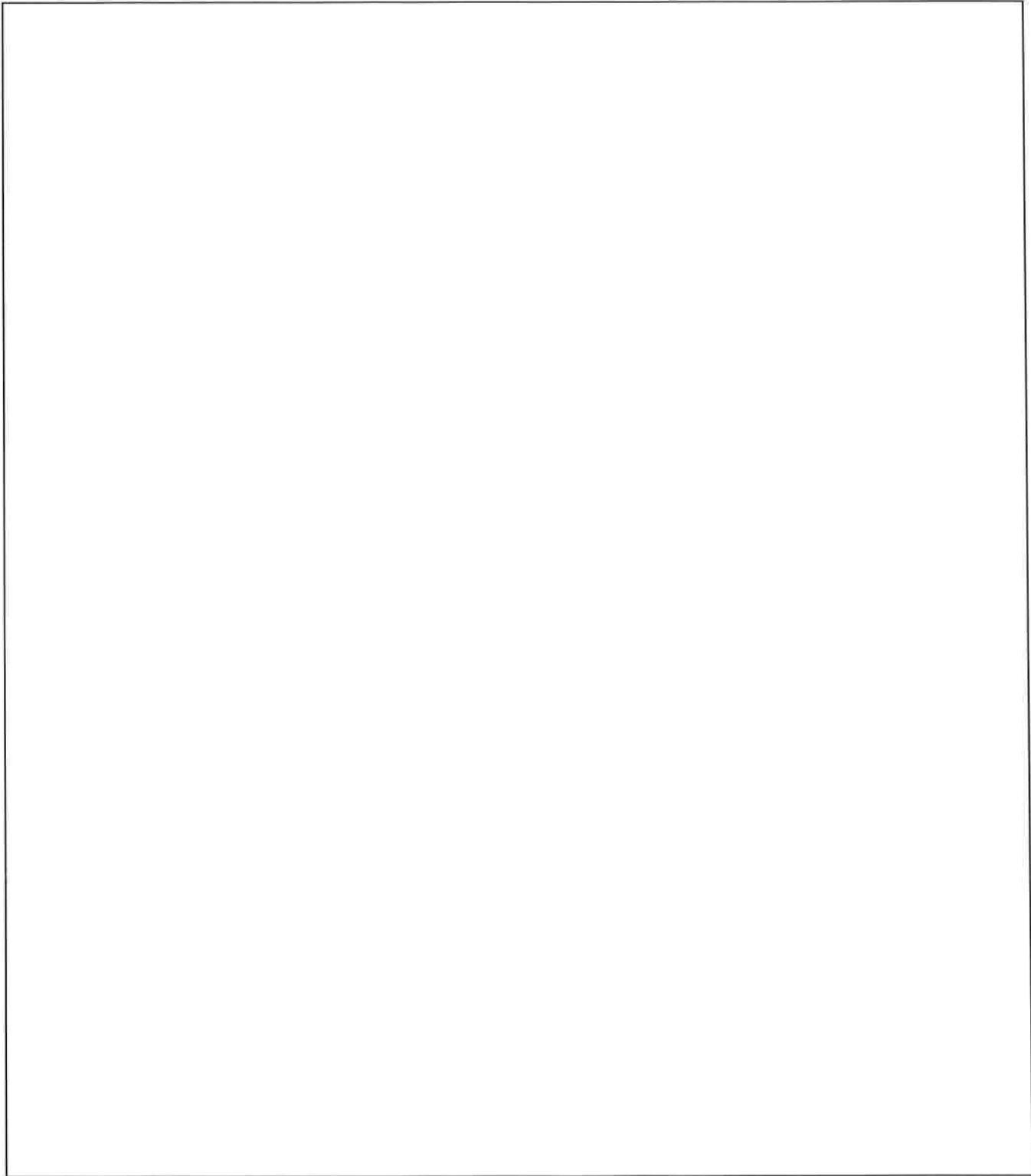

## Analysis

This bill amends the qualification criteria for an Alaska Performance Scholarship (APS) applicant by adding an option for career and technical education (CTE) to the academic curriculum; and inserts a definition for career cluster.

The CTE academic curriculum options include:

(Option 1) substituting one CTE course credit for one standard course credit of social studies in the Math and Science Curriculum track;

(Option 2) substituting two CTE course credits, one year of which includes two semesters of sequentially more rigorous content within a career cluster, for two course credits of a world language in the Social Studies and Language Curriculum track; and

(Option 3) creates an additional Social Studies and Language Curriculum track that includes substituting one CTE course credit for one standard course credit of social studies, in addition to two years of a world language.

For the postsecondary level, this bill raises the award amounts for all three levels and removes the requirement for a college entrance exam. Additionally, the eligibility period for receiving the scholarship is extended from six to eight years.

The bill also directs the Alaska Commission of Postsecondary Education (ACPE) to evaluate awardees' grade-point averages after two semesters providing the opportunity for the award to increase based on postsecondary performance.

The department would need to make the necessary regulation changes to bring APS regulations into conformity with the addition of CTE to the academic curriculum, award dates, and deadlines. There is a one-time increment of \$6.0 to implement the necessary regulation changes.

The bill provides the continuation of a grant allocated to the Galena City School District for the Galena Interior Learning Academy (GILA) by DEED from the Alaska Workforce Investment Board (AWIB) as part of the Technical Vocational Education Program (TVEP) grant in the amount of \$960.7 annually.

Section 14 of this Act, TVEP funding, takes effect immediately. This bill also contains a retroactive clause if the Act takes effect after June 30, 2024.

## Analysis

The proposed legislation amends existing AHFC statutes to authorize creation of a nonprofit subsidiary corporation for the purpose of sustainable energy development through a sustainable energy fund, identified as the "Alaska Energy Independence Fund." The subsidiary will use federal grants, AHFC deposits, unrestricted loan payments, interest, or other income earned on loans, investments, or assets of the fund to make loans, secure bonds, loan guarantees, credit enhancements, equity capital, indirect funding, and other financial products.

This fiscal note identifies the initial capital investment and budget authority necessary for the subsidiary to achieve its stated purpose. Based on analysis of prior bills introduced in the Alaska Legislature, (SB123, HB 170), the Alaska Energy Independence Fund would require a total of \$40 million in FY2024 Capital funding, with \$20 million in federal receipt authority and \$20 million in unrestricted general funds. The unrestricted general funds are required for the initial capital of the program and fund initial program start-up costs.

Additionally, this fiscal note requests the required operating funds as Unrestricted General Funds (UGF). There would be annual operating costs, estimated to be approximately \$450.0. Operating costs would include two PCNs for a Program Manager (Range 22) and a Program Assistant (Range 17) at an annual cost of \$300.0. As well as, anticipated travel, contractual services, and supply expenses in the operating budget for a total of \$150.0.

Revenues generated from the fund are expected to sustain operating expenses starting in FY2025. Operating budget authority will be necessary for these operating expenses.

Additional federal and statutory designated program receipt authority may be necessary in subsequent fiscal years as related funding opportunities are identified.

This bill amends AS 44.19 relating to the Office of the Governor to establish an Alaska Military Affairs Commission in the Office of the Governor. The lieutenant governor would serve as chair of the commission. The bill also amends AS 44.66.010 relating to expiration of state boards and commissions to provide for a June 30, 2030, sunset date for the commission.

The commission consists of nine members: three state employees (including the lieutenant governor) and six non-state employees.

The bill requires that the commission shall meet at least quarterly. Though not explicitly stated in the bill, it is assumed the commission may meet and transact business electronically. While the members serve without compensation, they are entitled to per diem and travel expenses authorized for boards and commissions under AS 39.20.180.

Should this bill pass, the lieutenant governor's office would be responsible for staffing the commission, including scheduling and planning commission meetings, preparing meeting materials and minutes, making non-state member travel arrangements for any in-person meetings, and securing meeting locations. Therefore, this fiscal note assumes the following associated costs:

Personal Services

Given the work and because the lieutenant governor is designated as the commission chair, an Anchorage-based part-time special assistant, Range 22, would be needed. Annual position costs are estimated at \$61.0, of which \$37.0 is salary, and \$24.0 is benefits.

Travel

Annual travel and per diem costs for commission members will depend on the members' location and ability to participate electronically.

It is assumed at least one commission meeting per year will be face-to-face. This fiscal note further assumes an average travel cost of \$1.0 per member for the six non-state members, and the lieutenant governor and one staff to attend each face-to-face meeting for an annual cost of \$8.0. These costs may be mitigated by transacting business electronically, thereby limiting total travel.

Contractual Services

Contractual services costs will include meeting facilities and office space rental, state enterprise productivity rates (telephone, computer services, etc.), equipment rental, and recording services with an estimated annual cost of \$15.0.

Commodities

Commodities costs include office and meeting supplies and office equipment for the new special assistant at \$2.5, of which \$2.0 would be one-time costs.

**Analysis**

This bill would amend AS 14.03.127 funding for internet services to provide Alaska school districts with funding to assist eligible schools in their district reach up to 100 megabytes per second (Mbps) download speed for internet services.

In FY2023, the Alaska School Broadband Assistance Grants (BAG) Program offered \$6,611.9 in grant funding to 151 eligible Alaska schools to reach up to 25 Mbps download speeds. In FY2024, the Alaska School Broadband Assistance Grants (BAG) Program offered \$6,797.9 in grant funding to 136 eligible Alaska schools to reach up to 25 Mbps download speeds.

In FY2025, the Conference Committee estimates \$25,000.00 in grant funding would be needed for all eligible BAG schools to reach up to 100 Mbps download speeds and that amount will increase to \$40,000.0 in the out-years. Additionally, one-time funding of \$6.0 would be provided for updating associated regulations, as estimated by the Department of Education and Early Development. A 1.5% indirect rate adjustment of \$375.0 for FY2025 and \$600.0 in the out years is also reflected in the fiscal note; this indirect rate is estimated by the Department to cover the costs of administering the grants.

This bill has an immediate effective date.

The RTO is required to submit for RCA approval a transmission cost recovery methodology, but if the organization fails to file the methodology by July 1, 2025, the RCA must establish the transmission cost recovery methodology.

This bill also amends state tax statutes to provide that generation facilities that only provide power to public utilities are not subject to state and local ad valorem, income, and excise taxes. The legislation also addresses AEA board composition, transitioning from a board comprised of Alaska Industrial Development & Export Authority (AIDEA) board members to a separate board with the required board composition specified in statute, along with additional details regarding board members, voting rights, and board vacancies. The powers of the AEA are also expanded to include the acquisition of energy storage facilities.

The RCA and the Department of Law's Regulatory Affairs and Public Advocacy Section (RAPA) are funded by the Regulatory Cost Charge (RCC), a statutorily capped assessment on utility revenues that covers the annual operational costs of the RCA and RAPA. This bill increases the RCC statutory cap from 0.7 to 0.98 percent for the RCA and from 0.17 to 0.22 percent for RAPA. This bill also increases the salaries of RCA Commissioners from range 27 to range 29.

RCA's enabling statutes are amended to (1) include refuse utilities among the entities for which the RCA must develop regulations setting for the adjustment of rates under a simplified rate filing procedure, (2) provide that RCA rate determinations may consider whether the purpose of the rate is to increase diversity of supply, promote load growth, or enhance energy security or reliability, (3) require RCA approval of a wholesale power agreement between a public utility and an independent power producer, with the RCA also required to ensure the agreement's power rate reflect any tax exemptions or government subsidies provided to the utility or independent power producer, and (4) require that costs incurred by cooperative electric utilities served by electric reliability organizations be allowed in rates (if approved by the utilities' board) in connection with new or purchased power from a renewable generation facility with a nameplate capacity of less than 15,000 kilowatts. Statutes governing electric reliability organizations (EROs) are amended to (1) add a requirement that an ERO must prioritize the reliability and stability of the interconnected bulk-electric system it serves while considering cost to the consumer, (2) eliminate requirements that RCA regulations governing EROs must require the ERO's tariff include standards for open access transmission and transmission cost recovery, and (3) provide that the RCA may not require an ERO for an interconnected bulk-electric system if total annual sales for load-serving entities operating in the system are less than 1,500,000 megawatts.

**Analysis**

Upon passage of this bill, the RCA will need to consider developing a regulatory scheme to guide the filing and review of Railbelt Transmission Organization (RTO) filings (i.e., a nondiscriminatory open access transmission tariff and a Railbelt backbone transmission system cost recovery mechanism). The RCA will need to revise regulations governing RCA rate determinations to (1) allow consideration of whether a rate is intended to increase supply diversity, promote load growth, or enhance energy security or reliability, and (2) allow cost recovery through rates for new or purchased power from a renewable generation facility with a capacity of under 15,000 kilowatts if incurred by a cooperative electric utility served by an electric reliability organization and approved by the cooperative’s board. The RCA will also need to revise regulations governing the review process for wholesale power agreements to ensure agreements between public utilities and independent power producers are subject to RCA approval and priced in a way that ensures tax exemptions and government subsidies are factored into the agreement’s power rates. The RCA will need to develop regulations setting out filing requirements, notice, and limits for refuse utilities under the simplified rate filing process. The RCA will also need to revise regulations governing electric reliability organizations to (1) ensure prioritization of the reliability and stability of the interconnected system served by the organization, and (2) eliminate requirements that the organization’s tariff include standards for open access transmission and transmission system cost recovery and retain requirements that the organization’s tariff include standards for non-discriminatory interconnection. If the RTO fails to develop and file a Railbelt backbone transmission cost recovery mechanism by July 1, 2025, the RCA will need to develop the cost recovery mechanism after notice and a public input process.

Passage of this bill will also generate several filings from refuse utilities, Railbelt electric utilities, the electric reliability organization, and the RTO. Railbelt electric utilities will need to file tariffed charges for backbone transmission services based on the backbone transmission cost recovery mechanism developed by the RTO and approved by the RCA. The electric reliability organization will be required to file nondiscriminatory standards for interconnection. The RTO will need to obtain RCA approval of an open access transmission tariff and a backbone transmission cost recovery mechanism, as well as periodic updates to the tariff or cost recovery mechanism. Refuse utilities may file changes to rates under a simplified rate filing process.

*The budgets of the Regulatory Commission of Alaska (RCA) and the Department of Law’s Regulatory Affairs and Public Advocacy Section (RAPA) are funded by the Regulatory Cost Charge (RCC), a statutorily capped assessment on utility revenues that covers the annual operational costs of the RCA and RAPA. This legislation increases the RCC statutory cap from 0.7 to 0.98 percent for the RCA and from 0.17 to 0.22 percent for RAPA. In FY2025 and future years an additional \$98.0 in revenue collections is required to meet the projected baseline budget for RAPA with no change in operations. For purposes of this fiscal note, \$677.0 change in revenues is projected beginning in FY2026. This calculation is based on a five-year average of benefit, health insurance, and salary changes for the Commission’s staff and an average 2% growth in gross operating revenues of Alaska utilities.*

This legislation amends AS 44.12.010 by establishing Juneteenth Day as a legal holiday on the 19th of June. It is likely that the majority of employees covered by collective bargaining will have this holiday added to their collective bargaining agreements and that the Alaska Personnel Board adopt the holiday for partially exempt employees should this legislation pass.

The Department of Corrections manages 24-hour operations and employs Class 1 employees, defined under AS 23.400.200 as employees whose services may not be given up for even the shortest period of time. The Department's mission requires 24-7 coverage for the oversight of offenders under its supervision.

The majority of Department's employees who are Class 1 are overtime eligible, therefore the Department anticipates that the passage of this legislation will have a fiscal impact of \$525.6. This amount represents the average of three holidays including both the holiday premium pay and shift differential overtime for those employees required to work on a holiday to ensure the 24-7 coverage; correctional officers, medical, mental health, maintenance, kitchen workers, and other critical support staff.

## Analysis

This bill establishes a new state holiday under AS 44.12.010. This fiscal note reflects the costs to the Alaska Department of Fish and Game (ADF&G) for the additional paid state holiday for employees that manage 24-hour facilities or are otherwise Class 1 employees, defined under AS 23.40.200 as employees whose services may not be given up for even the shortest period of time.

ADF&G has staff across its divisions and multiple components that fall into the category of employees above. For the Division of Commercial Fisheries, this includes staff on board vessels and full-time and seasonal employees out in the field during the field season. The Division of Sport Fish has employees who staff 24-hour facilities such as the William Jack Hernandez and Ruth Burnett hatcheries in Anchorage and Fairbanks, respectively. The Division of Sport Fish, Division of Wildlife Conservation, and the Subsistence Section also have employees out during field season similar to the Division of Commercial Fisheries.

Cost estimates were analyzed on an average of actual holiday overtime pay as applicable for the categories of employees noted above for: July 4, 2022, October 18, 2022, and January 16, 2023. However, some divisions were adjusted to account for seasonal staff operating in field camps across the state during the season in which the holiday will occur. The amount of additional overtime is minimal and the majority of the overtime can be attributed to the holiday.

The average for each division is as follows:

- Division of Commercial Fisheries: \$62.5 (UGF)
- Division of Sport Fish: \$2.1 (UGF) \$7.3 (Fed) \$2.4 (Other)
- Division of Wildlife Conservation: \$6.8 (Fed) \$2.2 (Other)
- Subsistence Section: \$0.2 (UGF) \$0.1 (Fed)

For a total of \$83.6 in personal services costs to the department.

This bill proposes to create a new state holiday under AS 44.12.010.

An additional state holiday will directly increase personnel costs to the Department of Family and Community Services for the management of 24-hour facilities and services. Employees working at the department's 24-hour facilities (Alaska Psychiatric Institute, Division of Juvenile Justice facilities, Alaska Pioneer Homes) along with employees working for the Office of Children's Services and in Probation Services for the Division of Juvenile Justice will be paid time-and-a-half versus regular pay for all hours worked on the holiday.

Based upon the average holiday personnel cost related to staffing 24-hour facilities and services on the recent FY2024 holidays (Thanksgiving, Christmas, New Years Day, and Martin Luther King Day), the Department of Family and Community Services estimates additional personnel costs of \$103.5 per year if an additional State of Alaska holiday is implemented.

Analysis

This legislation amends AS 44.12.010 by establishing Juneteenth Day as a legal holiday on the 19th of June. It is likely that the majority of employees covered by collective bargaining will have this holiday added to their collective bargaining agreements and that the Alaska Personnel Board adopt the holiday for partially exempt employees should this legislation pass.

All employees within the Department of Public Safety, per AS 23.40.200, are considered class 1 which defines services which cannot be given up for even the shortest period of time. The majority of department employees are overtime eligible. There will be fiscal impact with the passage of this legislation. To estimate fiscal impact, the department considered the actual cost of overtime, premium pay, and shift differential for three holidays.

The department anticipates that the passage of this legislation will have fiscal impact of \$124.3, which represents an average overtime, premium pay, and shift differential of the three above holidays for employees will be required to work the new holiday.

## Analysis

Summary:

This bill would reinstate the Citizens' Advisory Commission on Federal Management Areas in Alaska (CACFA), which sunset in 2021 and had been unfunded and inactive for several years prior to that. The bill also repeals a prior expiration date for the Commission, sets terms for initial commission members, and sets an effective date for the act.

EXPENDITURES

The CACFA Executive Director will be a large project coordinator position housed in the Department of Natural Resources Office of Project Management and Permitting (OPMP) and is needed to carry out the intent of the bill. The position reports to the commission, would coordinate commission feedback, and respond to citizen inquiries and concerns about actions on federal lands.

Personnel:

A Large Project Coordinator/CACFA Executive Director (Range 23) will establish and administer the program, including coordination of commission input and responses to public concerns.

Travel costs:

The Department anticipates \$10.0 in annual travel expenses to hold public meetings.

Services:

Contractual costs for office space, telephones, core service charges and related expenses for new positions are \$15.0 per position annually. Starting in FY2026, an additional \$30.0 will cover legal services associated with CACFA through an RSA with the Department of Law.

Commodities:

Supply costs, including computers, are \$1.5 per person annually. Initial office set up is a one-time cost of \$5.0 per staff.

## Analysis

The bill prohibits the use of firefighting substances containing PFAS, except in specific cases such as oil and gas facilities unless safer alternatives are mandated by the state fire marshal.

Additionally, it establishes a reimbursement program under the Department of Environmental Conservation. This program will aide communities with populations under 2,000 and off-road systems, or those with partially state-funded fire safety projects, enabling them to hire third-party contractors for PFAS disposal. The Department will prioritize reimbursement for disposal activities, including equipment replacement.

Regulations will need to be developed to establish the reimbursement program. Current division staff will be used to process the reimbursements.

Reimbursement activities required under the bill would require an additional state expenditure. FY25 Capital costs are recommended to come from 1004 (UGF) as DEC cannot absorb this ask within our existing resources.

Cost estimates are based on a range of costs from ~\$6.0 for disposal via mostly road, to ~\$10.0 by mostly barge, and ~\$15.0 by mostly air to dispose of the 35 gallons (5-gallon AFFF container in an overpack container and the 30 gallons substance in the firefighting equipment to be drained into a 55-gallon drum). These estimates do not include site survey cost estimates. The list of communities that received Project Code Red equipment appears to require more air travel than road or barge and, therefore, the estimate provided reflects a higher average between the barge and air options. Additional funding needs were included to account for the disposal of equipment and the replacement of contaminated equipment.

Depending on the utilization of this program for the disposal of PFAS, contaminated equipment, and the replacement of contaminated equipment additional capital funding and personnel may be required.

\*\*\*

In addition to program costs, there is the real potential for liability costs associated with PFAS disposal that cannot be quantified at this time but, under reasonable consideration, could far exceed the costs of this fiscal note should a spill or mishandling of the PFAS-containing firefighting substance occur, even outside of the state's control.

## Analysis

This legislation would make Alaska a member state of the Interstate Physical Therapy Licensure Compact, which would allow Alaska physical therapists and physical therapist assistants with unencumbered licenses who have had no adverse action against their license within two years to apply for and work under compact privilege in any other member states; and would allow the same for physical therapists and assistants meeting the same requirements to work in Alaska. Alaska will have the ability to set fees for professionals from other member states requesting compact privilege. Those professionals will be required to follow all Alaska laws, and the Alaska Board of Physical Therapy & Occupational Therapy will retain full jurisdiction over these professionals regardless of whether they are practicing under an Alaska license or a compact privilege.

If this bill passes, a permanent Administrative Assistant 1 would be required to assist with processing fingerprint cards and other administrative tasks.

If the bill passes the following expenses will be incurred:

## Personal Services:

FY25 and beyond: \$80.0 for one full-time Administrative Assistant 1 (R12)

## Services:

FY25 only: \$2.5 for legal costs to amend regulations, printing, and postage

FY25 and beyond: \$25.0 for core services per position

Commodities: FY25 only: \$10.0 for one-time set up costs for the new Administrative Assistant 1 position

Licensing fees for each occupation are set per AS 08.01.065. The total amount of revenue collected approximately equals each occupation's actual regulatory costs. Professional licensing programs within the Division of Corporations, Business and Professional Licensing are primarily funded by Receipt Supported Services – fund source 1156 Rcpt Svcs (DGF).

Analysis

This legislation would expand the telehealth provisions currently allowed to non-Alaska-licensed physicians under statute to apply to members of the non-Alaska-licensed physician’s multidisciplinary care team so that those members can also provide telehealth services to Alaska patients under the circumstances listed in that section without obtaining an Alaska license. While the non-Alaska-licensed physician is subject to disciplinary action by the Alaska State Medical Board, all members of the team would be subject to disciplinary action by the Department of Commerce, Community, and Economic Development. This bill creates new sections that provide the grounds for disciplinary sanctions against these team members and what those disciplinary sanctions can be.

The addition of a renewal to the currently perpetual Telemedicine Business Registrations will bring in approximately \$91.0 in additional licensing revenue. The division does not anticipate the need for additional staffing to process these renewals and plans to automate the renewal process by adding the renewal to the business license renewal process. This will ensure registrants are in full compliance with their business license and, if applicable, the corporate registration. In this fiscal note revenues are shown to equal expenditures because any increases in revenue from Telemedicine Business Registrations would offset program expenses when fees are set according to AS 08.01.065.

If this legislation passes, one full-time permanent Investigator 3 will be required to take on investigations of complaints on unlicensed multidisciplinary care team members.

## Analysis

This bill will change the authorization method of specialty organization license plates by removing the requirement that each plate go through the legislative process and gives DMV the authority to establish the criteria and procedures for plate development and design by regulation.

The Division of Motor Vehicles does not know what the demand will be from specialty organizations taking part in acquiring specialty plates in the future under the bill provisions, the total revenue generated per plate sold is unknown. However, for the purposes of this fiscal note, actual FY2022 specialty plate sales and participating current organizations were used to provide estimates.

DMV expects IT programming and user testing of DMV's database to cost 100 hours at \$125/hour for a total of \$12,500 per each new organization plate type requested. Creation of regulations, updates to training manuals, website, staff and law enforcement education, new forms, and public outreach will cost approximately \$1,500 per each new organization plate type; for a total development cost of \$14,000 per different plate.

**Assumptions:**

\*For the purposes of this fiscal note, and the potential financial implications of the bill passage, the following assumptions were used in calculating the shown numbers:

1. Use actual FY2022 specialty plate sales = 833 total.
2. Use the actual number of different organizations that currently have specialty plates sales attributed to them (16) and reflect what those annual sales are if they applied for new plate designs under the new bill process (meaning: assume the universe of different organizations applying for new plate designs is 16, plus the 3 new specialty plates being proposed in this bill, annually (19 total)).
3. Assume that those organizations will still want their current per plates premiums to be in effect. For example, if an organization is charging \$30 over and above normal plate charges as a revenue source, those same margins will be in effect with now charging \$100 per plate (per the provisions of the bill), plus the \$30 organizational premium on top of that.
4. Assume the current development costs of \$14,000, per different plate, times 19 new plate types per year.

**Analysis:**

\* 833 plates sold times \$100 (as called for in the bill) = \$83,300 annually, plus \$36,730 annually charged by organizations as a dedicated plate premium = \$120,030 annually in revenue collected. (Assumption based on actual FY2022 sales, and actual FY2022 collected plate premiums.)

\* Assume 19 submissions per year for new plates, with a development cost of \$14,000 per new plate type = \$266,000 annually. This figure would match expenses paid by new plate requesters in the development process called for in Section 1 (C) of the bill, annually.

Expenses incurred = \$266,000, Income paid by requesting entities = \$266,000.

Recap of bill fiscal impact: Annual expenses = \$266,000. Annual income = \$386,030 (\$120,030 + \$266,000).

## Analysis

The bill amends state law to require the Department of Public Safety (DPS) to employ at least two persons to investigate missing and murdered indigenous persons. The investigators would also be required to act as liaisons between law enforcement agencies, communities, and federally recognized tribes. The department currently employs four investigators and two tribal liaisons that focus on Trooper specific cases, community outreach and collaboration, and missing person initiatives statewide.

The bill establishes a Missing and Murdered Indigenous Persons Review Commission within DPS, and the department anticipates it would need a position to coordinate and administer the commission and assist in drafting the requested report.

The bill requires DPS to conduct a needs assessment to determine how to increase protective and investigative resources for reporting cases of missing and murdered indigenous persons within the state criminal justice system to reduce barriers and increase information sharing.

The department would offer an open procurement for a professional services contract for the needs assessment at an estimated cost of \$400.0 for the assessment, travel for the contractor and stakeholders, and preparation of a report to the legislature. The contractor will coordinate and lead meetings with tribal and local law enforcement agencies, tribes, and tribal organizations to identify barriers and determine methods increased reporting and investigation of cases involving missing and murdered indigenous persons. The contractor will be responsible for the following deliverables:

- Provide a project plan outlining the approach, timeline, resources, and methodologies to be used for the needs assessment and providing regular project status reports.
- Develop and implement a strategy for engaging with local, state, and tribal governments, as well as indigenous communities statewide to include a plan for communication, collaboration, and feedback.
- Provide for travel and meeting scheduling for all meetings related to the project, including logistics for accommodations and meeting agendas, with a focus on visiting indigenous communities.
- Provide data collection and analysis of relevant data from various sources, including law enforcement records, social services, and community input to include a thorough analysis of the data to identify trends, gaps, and needs, specifically related to missing indigenous persons.
- Provide a report detailing the outreach efforts made to communities statewide and the feedback received.
- Prepare a comprehensive report detailing the findings of the needs assessment to include identified needs, gaps, and recommendations for improvement, specifically focusing on resources for reporting missing indigenous persons.
- Deliver a final presentation of the findings to the Governor, the legislature, and other key stakeholders on how the recommendations can be implemented to include timelines, required resources, and potential challenges, with a focus on increasing protective and investigative resources for reporting missing indigenous persons.

**Analysis**

The proposed legislation provides AHFC with the authority to acquire or purchase a building currently occupied -- as required by AS 18.55.100(d) and AS 18.56.090(d). AHFC is requesting a one-time \$8 million federal capital appropriation for the purpose of purchasing a multipurpose/maintenance facility. AHFC has received permission from the Department of Housing and Urban Development (HUD) to use available federal funding for this purpose.

Along with the capital federal increment request, AHFC is asking for a federal operating increment of \$200.0 starting in FY2025. The increment covers the ongoing operating expenses of the facility and includes utilities, property insurance, and other maintenance costs.

Senate Bill 259 would provide salary increases to the salaries listed in Alaska Statute (AS) 39.27.011(a). The salaries would be updated accordingly by the Department of Administration, Division of Personnel and Labor Relations, in line with the salary increases provided to the supervisory bargaining unit under AS 23.40.215.

The supervisory bargaining unit agreement established May 9, 2024 sets a five percent cost of living allowance increase, as well as a one step increase for Fiscal Year 2025.

The Senate Finance CS for SCR 10 makes several changes to the original bill; however, for the purpose of this fiscal note, the only relevant change is the make-up of the task force membership. CS for SCR 10 increases the task force membership from seven to thirteen members, specifically increasing the number of public members from two to nine. The membership is now comprised of four legislators, nine public members, and three non-voting ex-officio members: the Commissioners of Commerce, Fish and Game, and Revenue, or their designees.

The legislation resolves that non-legislative members serving on the task force "may seek reimbursement for per diem and travel expenses from the member's respective organization". While three of the public members do not belong to an organization, the resolution further stipulates that the task force shall meet virtually or use other electronic means; therefore, there is no fiscal change anticipated as a result of this committee substitute and no new funds are necessary to support the work of this task force.
