FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

Analysis

This bill amends AS 14.03 relating to public schools by adding a new section requiring the state Board of Education to develop and review a statewide civics education curriculum and assessment, and requires students to complete one semester of civics education under the new curriculum and achieve a passing score on the new assessment to receive a high school diploma.

Passage of this bill would not impact the Office of the Lt. Governor. Therefore, a zero fiscal note is submitted.
