## FISCAL NOTE ANALYSIS

## Analysis

This bill 1.) separates the Cook Inlet set gillnet permit holder category into two new administrative areas, 2.) conducts an election for permit holders in the new administrative area to determine if they would like a buyback program, and 3.) implements a buyback program for the new administrative area.

If passed, CFEC will -

- \* conduct a regulation project in the fall of 2023 that directs the three aforementioned bill components
- \* by November hold an application period to determine permit holders for a new administrative area in Cook Inlet
- \* by January 1, determine permit holders for new Cook Inlet administrative area and remaining Cook Inlet area
- \* by February develop and mail election ballots to permit holders in new area
- \* in February hold informational meetings in the Kenai Peninsula
- \* post election notices in areawide newspaper
- \* by April 1 conduct election
- \* by early May announce election results

Assuming permit holders approve a buyback program in an election, CFEC will -

- \* receive and administer external funds for a buyback
- \* if funding is received, administer a buyback application period
- \* adjudicate appeals for buyback applicants denied into the buyback
- \* conduct lottery of successful applicants to the buyback
- \* administer payments to successful lottery winners to the buyback
- \* retire those permits that are selected through the buyback lottery
- \* report back to the Legislature on the program

It is anticipated the work would require an additional temporary position to work on the program in CFEC's adjudications section. CFEC would likely hire a paralegal to assist in the work. It is anticipated the program will take two fiscal years to complete. Other anticipated costs include travel, advertising, publications, and office set-up.

The bill determines the buyback amount and allows for administrative expenses to be paid from the external source assumed to be federal funding. Assuming the maximum number of permits (200) are purchased for \$260,000 as specified by the bill through up to three years, \$52 million of federal receipt authority will be needed. Administrative costs will be funded through the capital appropriation via Capital Improvement Project (CIP) receipts.
