## FISCAL NOTE ANALYSIS

## Analysis

This legislation only makes changes to AS 08.48: *Architects, Engineers, Land Surveyors, and Landscape Architects*; and primarily updates wording to be more aligned with the times and processes already in effect under the Alaska Board of Registration for Architects, Engineers, and Land Surveyors.

If the bill passes, the division would incur \$4.6 in one-time expenses for printing, postage, and legal costs for regulations costs. These costs would be managed within the division's existing authority.

*Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services (fund source 1156 Rcpt Svcs (DGF)). Licensing fees for each occupation are set per AS 08.01.065. The total amount of revenue collected approximately equals each occupation's actual regulatory costs.*
