FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION**Analysis**

This bill increases the base student allocation (BSA) under AS 14.17.470 by \$300, from \$5,960 to \$6,260 (whole dollars). The \$300 BSA increase results in a projected increase in State aid funding for Mt. Edgecumbe High School (MEHS) of \$218.0 in FY2025.

As a division of the Department of Education and Early Development, MEHS' state aid is budgeted as interagency receipts. This fiscal note increases their budgeted interagency receipt authority by the \$218.0 projected increase.

The pupil transportation program per student amount changes under AS 14.09.010(a) does not impact MEHS.

This bill takes effect July 1, 2024 (FY2025).
