FISCAL NOTE ANALYSIS

**Analysis**

This is a bill that will add additional bidder preference into Title 36 (Public Contracts) Chapter 30 (State Procurement Code). The Office of Procurement and Property Management anticipates some additional staff time to incorporate and educate public agencies on the new bill, should it become law, but believes the agency can absorb the cost of these efforts in the existing budget. Accordingly, Office of Procurement and Property Management submits a zero fiscal note. Implementation and changes to policies expected to be finalized within 180 days after passage.
