FISCAL NOTE ANALYSIS

STATE OF ALASKA
2024 LEGISLATIVE SESSION

Analysis

This bill authorizes the Department of Education and Early Development (DEED) to transfer real property to a broader group of entities. It amends AS 14.07.030(a)(6) by removing the limitation on the entities to which DEED has authority to transfer real property. Currently, DEED is limited to transfer interests in land to federal agencies, state agencies, or to political subdivisions.

A one-time funding increment of \$6.0 would be needed for updating associated regulations in FY2025.

This bill has an immediate effective date.
