FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION

Analysis

This legislation seeks to commemorate the life and legacy of the late Congressman Don Young by renaming the Fairbanks International Airport (FAI). Airport staff reviewed the necessary changes that would occur after a naming was approved. Those changes include replacing all airport signage (inside and out), decals, collateral materials, time and temperature sign panels, as well as other administrative details needed to transition.

FAI staff estimate the cost of transitioning signage and materials at the following (numbers in thousands):

Existing signage update:	\$300.0
New welcome sign:	\$150.0
Collateral materials:	\$20.0
Vehicle logos:	\$80.0
<u>Safety/uniforms:</u>	<u>\$50.0</u>
<b>Total:</b>	<b>\$600.0*</b>

*\*This estimate does not include a commemorative display such as the one centrally located at Ted Stevens International Airport with a bench, statute, and signage.*

Renaming would also necessitate updates to 17 AAC 43 for conforming changes to airport citations in regulation.
