FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION

**Analysis**

The bill seeks to increase production and consumption of Alaska agricultural and seafood products through various means. The bill would require municipalities receiving State funds to purchase Alaska agriculture and seafood products for a period of five years, assuming these products are similar in quality to products available outside the state. The bill would accomplish this by removing the current price differentiation limitations for a five year period.

The Alaska Seafood Marketing Institute does not anticipate fiscal impact from this legislation.
