FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2024 LEGISLATIVE SESSION

**Analysis**

This bill provides permission to the Department of Health to apply for a section 1115 waiver under 42 U.S.C. 1315(a), through Centers for Medicare and Medicaid Services (CMS).

With permission from the Alaska Legislature, the 1115 waiver is negotiated between the state and federal governments. The outcome of that negotiation will require the Department of Health to return to the Alaska Legislature to discuss outcomes and fiscal impacts. The Department of Health has resources to complete the CMS waiver process and negotiations. This results in a zero fiscal impact.
