Pursuant to adjournment the House was called to order by Speaker Tilton at 10:20 a.m.

Roll call showed 40 members present.

With respect for people of all faiths, let us pray:

where there is injury, pardon;  
where there is doubt, faith;  
where there is despair, hope;  
where there is darkness, light;  
where there is sadness, joy.

Grant that I may not so much seek to be consoled as to console, to be understood as to understand, to be loved as to love. For it is in giving that we receive, it is in pardoning that we are pardoned, and it is in dying that we are born to eternal life. Amen.
