"Dear Ms. Halterman:

Pursuant to the requirements of AS 37.14.005(c), this letter and the enclosed report describe the funding for FY24 Mental Health programs. The appropriations contained in HB 41 follow the FY24 Mental Health Trust Authority's funding recommendations for the State's integrated comprehensive mental health program. While the statute requires reporting only on general fund expenditures, information regarding expenditures of Authority receipts is also included in the attached report.

In HB 41 the Legislature appropriated all but two of the FY24 Mental Health Trust Authority recommendations.

Below are the funding differences in HB 41, relative to the Governor's FY24 Mental Health Trust Authority budget proposal.

Operating

- Legislature increased the Governor's request of \$667.0 GF/MH by an additional \$333.0 GF/MH to match the Trust's recommendation to support Crisis Now. However, the Legislature transferred the funding from the Behavioral Health Prevention and Early Intervention Grants allocation to the Behavioral Health Treatment and Recovery Grants allocation to maintain continuity with a similar reallocation of funds made in FY23;
- Legislature increased the Governor's request of \$333.0 GF/MH by an additional \$167.0 GF/MH to match the Trust's recommendation to further support Crisis Now by providing for new funding in the Emergency Programs allocation;
- Legislature added \$100.0 GF/MH for Peer Support Certification, which was absent from the Governor's request, to match the Trust's recommendation;
- Legislature approved the Governor's request for Aging and Disability Resource Centers in Senior and Disability Services. GF/MH funding

for these centers was originally recommended by the Trust at \$250.0, however, the amount was reduced to \$0.0 in the Governor's request;

•Legislature approved the Governor's request for IT Application/Telehealth Service System Improvements in Senior and Disability Services. GF/MH funding for these improvements was originally recommended by the Trust at \$63.0, however, the amount was reduced to \$0.0 in the Governor's request.

Capital

•Legislature approved the Governor's request for Special Needs Housing Grants in the Alaska Housing Finance Corporation. GF/MH funding for this grant program was originally recommended by the Trust at \$1,750.0, however, the amount was reduced to \$1,000.0 in the Governor's request;

•Legislature approved the Governor's request for Homeless Assistance Program in the Alaska House Finance Corporation. GF/MH funding for this program was originally recommended by the Trust at \$2,850.0, however, the amount was reduced to \$850.0 in the Governor's request.

House Bill 51 does not provide alternatives to aqueous film forming foam (AFFF) for firefighting. If AFFF is removed from a community, residents will have no capabilities to fight a large-scale fire. When balancing the environment and life and safety of Alaskans, this bill falls short by removing a lifesaving tool from the toolbox.

Accordingly, because this bill offers no alternatives to AFFF leaving Alaskans vulnerable to a preventable and unfortunate event to happen, I have vetoed the bill. I encourage the legislature to find a sustainable solution to this problem and not just a partial solution.

Additionally, I welcome Representative Wright to reintroduce the original draft of this legislation, which helped Alaskan consumers prepare for the upcoming transition of the heating, ventilation, air conditioning, and refrigeration industry to the next generation of refrigerants. I look forward to working with the legislature to address this issue when we begin the second half of the 33rd Alaska State Legislature in January.

The amendments expand the widespread flooding disaster to include the Northwest Arctic, Fairbanks North Star, and North Slope Boroughs; City of Galena; and the Iditarod, Lower Kuskokwim, Lower Yukon, Yukon-Koyukuk, and Bering Strait Regional Education Attendance Areas. The letters, amended declarations, and initial finance plans were copied to the Finance Committee Co-chairs and are on file in the Chief Clerk's office.

A Declaration of Disaster Emergency dated August 8 and accompanying letter dated August 9, regarding record flooding of Mendenhall Lake and Mendenhall River, were received and are on file in the Chief Clerk's office.

"President Stevens and Speaker Tilton:

On May 13, 2023, I declared a State Disaster Emergency for the Alaska Gateway, Yukon Flats, Copper River, and Kuspuk Regional Education Attendance Areas (REAA) to assist in response to moderate and severe/record flooding from ice jams and rapid snowmelt that impacted the Taylor Highway near Chicken, the City of and Native Village of Eagle, the unincorporated community of Circle, the unincorporated community of Glennallen, and the unincorporated community of Crooked Creek. The declaration authorizes funds to be made available for the State's public assistance program for emergency response and protective measures and temporary and permanent infrastructure repairs, the State's individual assistance program, to repair or replace damaged homes and essential personal property, and temporary housing, to support homeowners and renters displaced from their homes, and for administrative and disaster management expenses.

The 2023 Spring Flood Disaster was declared a Federal Disaster by the President of the United States on August 23, 2023. I am requesting an initial Federal Authorization of \$13,182,180 based on the joint FEMA-State preliminary damage assessment.

The total estimated disaster-related permanent response and recovery costs for this disaster have been identified in the joint FEMA-State

preliminary damage assessment that was conducted this summer, however additional damage may come to light once the work is evaluated for specific disaster awards. Therefore, I request concurrence from the Legislature to increase the funding limitation for this disaster to \$13,182,180 of Federal Authorization along with an increase of \$4,385,933 to the original \$5 million from the Disaster Relief Fund (DRF) pursuant to Alaska Statute (AS) 26.23.020(i) and (k), and per AS 26.23.025(a). This initial finance plan is attached.

The Division of Homeland Security and Emergency Management (DHS&EM) will continue to work with all jurisdictions and state agencies to determine community response and recovery needs.
